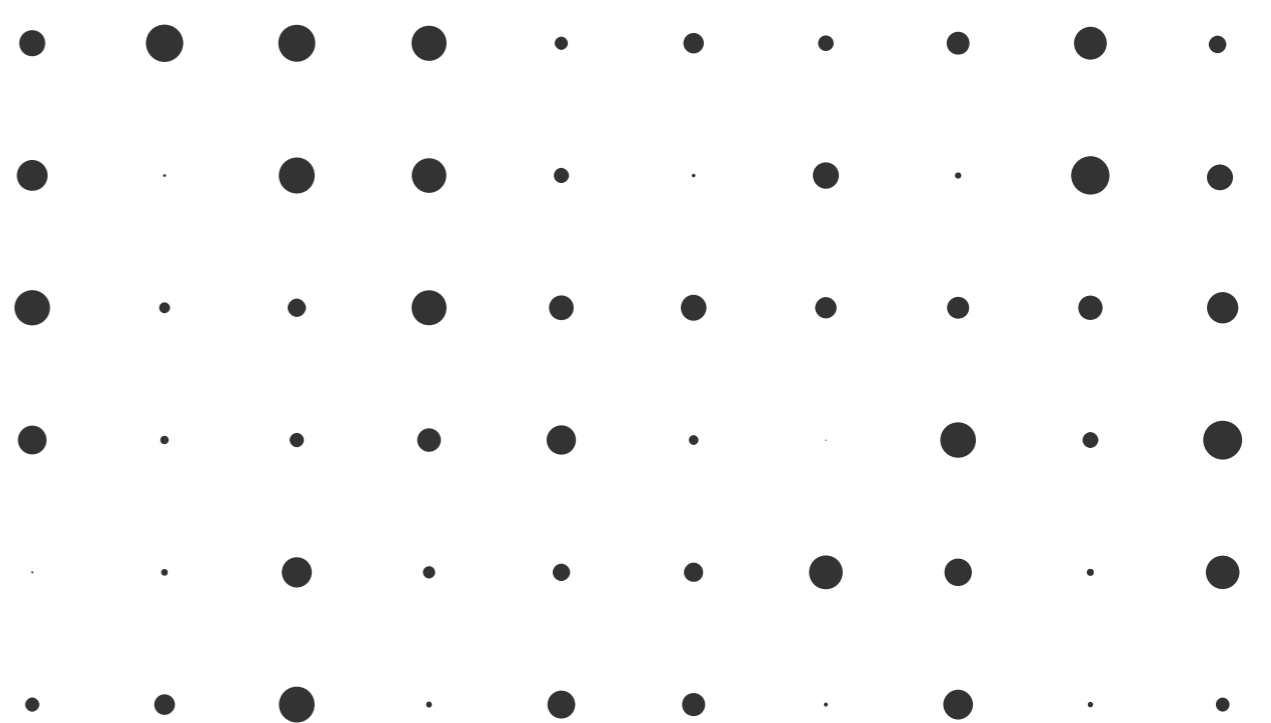

CONFIDENCE

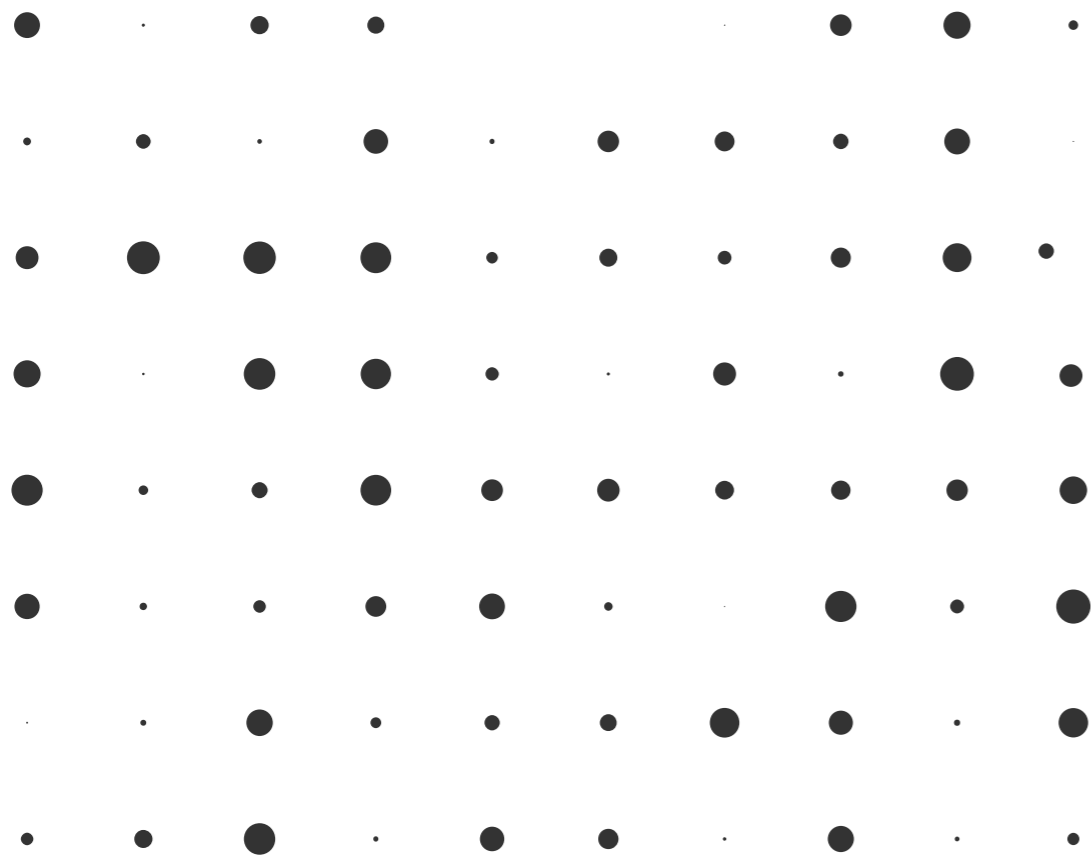

EDUCATION

Nicole completed her LLB degree in 2009 through UNISA. Subsequent to Nicole been declined an application form for pupillage to be an advocate and fulfilling her life long dream, she was compelled to pursue a career as an attorney. After 3 months serving articles at Macintosh Cross and Farquharson attorneys, Nicole decided that she needed more challenges in her quest and subsequently decided to seek employment at Maponya Attorneys.

Despite Maponya attorneys having no vacancies, Nicole approached the CEO convincing him that she needed the skills and magistrate court experience their firm provided to their candidate attorneys. Nicole opted to serve two years articles instead of one year with the aim of fully understanding the court processes and procedures. She was admitted as an attorney in July 2011 and worked two and a half years as an attorney. Nicole then pursued her dream and applied for pupillage to be an advocate and was duly admitted as an Advocate in July 2014. Due to lack of financial support Nicole did not do her pupillage but opted to work at Lonmin Mines as a Legal advisor. In August 2014 she started practicing as an Advocate banking on the work experience she gained from Maponya attorneys, Iqbal Mohamed attorneys and Honey Attorneys. Nicole practiced as an advocate for five years and has appeared in 2000 High Court personal injury cases, several divorce and labour law cases. The majority of her opponents are senior counsels and has several successful judgments against senior counsels.

Nicole then in April 2019 converted from an advocate to an attorney in terms of the Legal Practice Act NO. 28 of 2014.



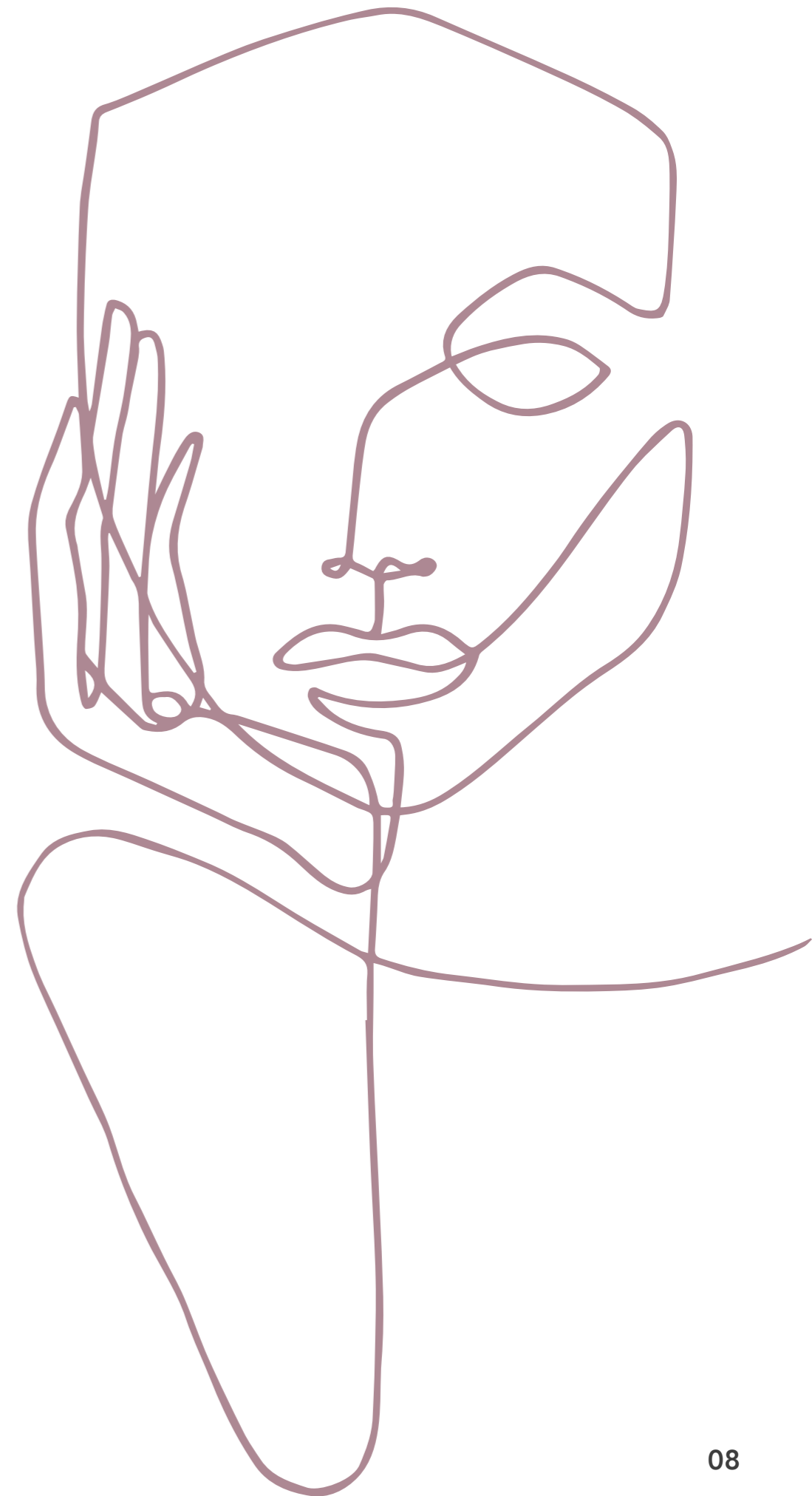
Pro Bono Work

We aim to help non-profit organizations so that they in turn can help others. We support pro bono clinics and focus on representing destitute woman needing legal advise and representation.



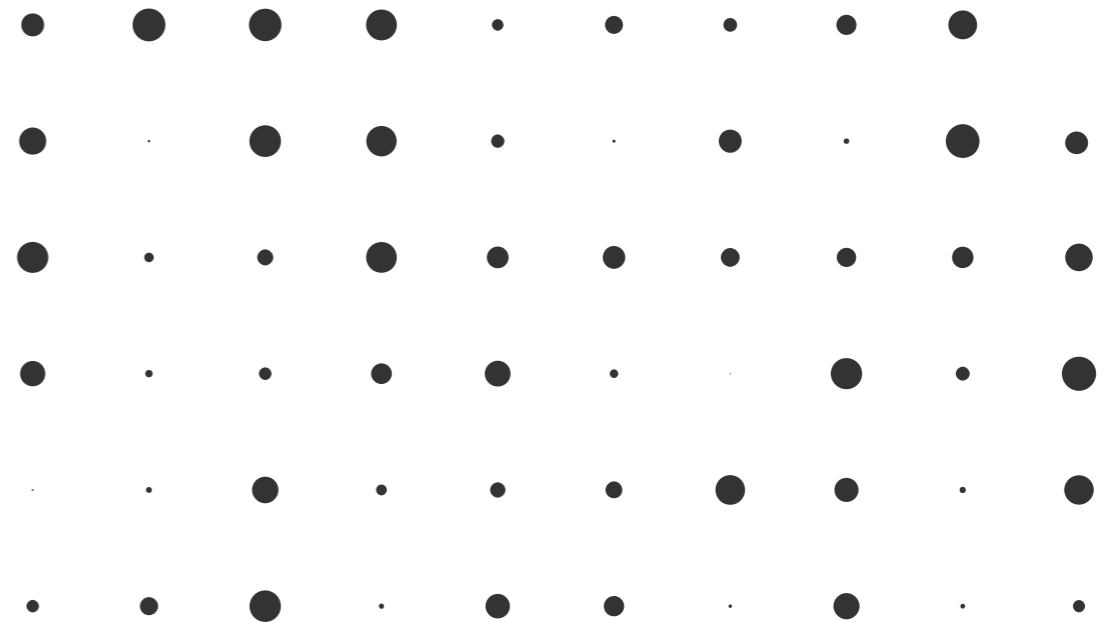

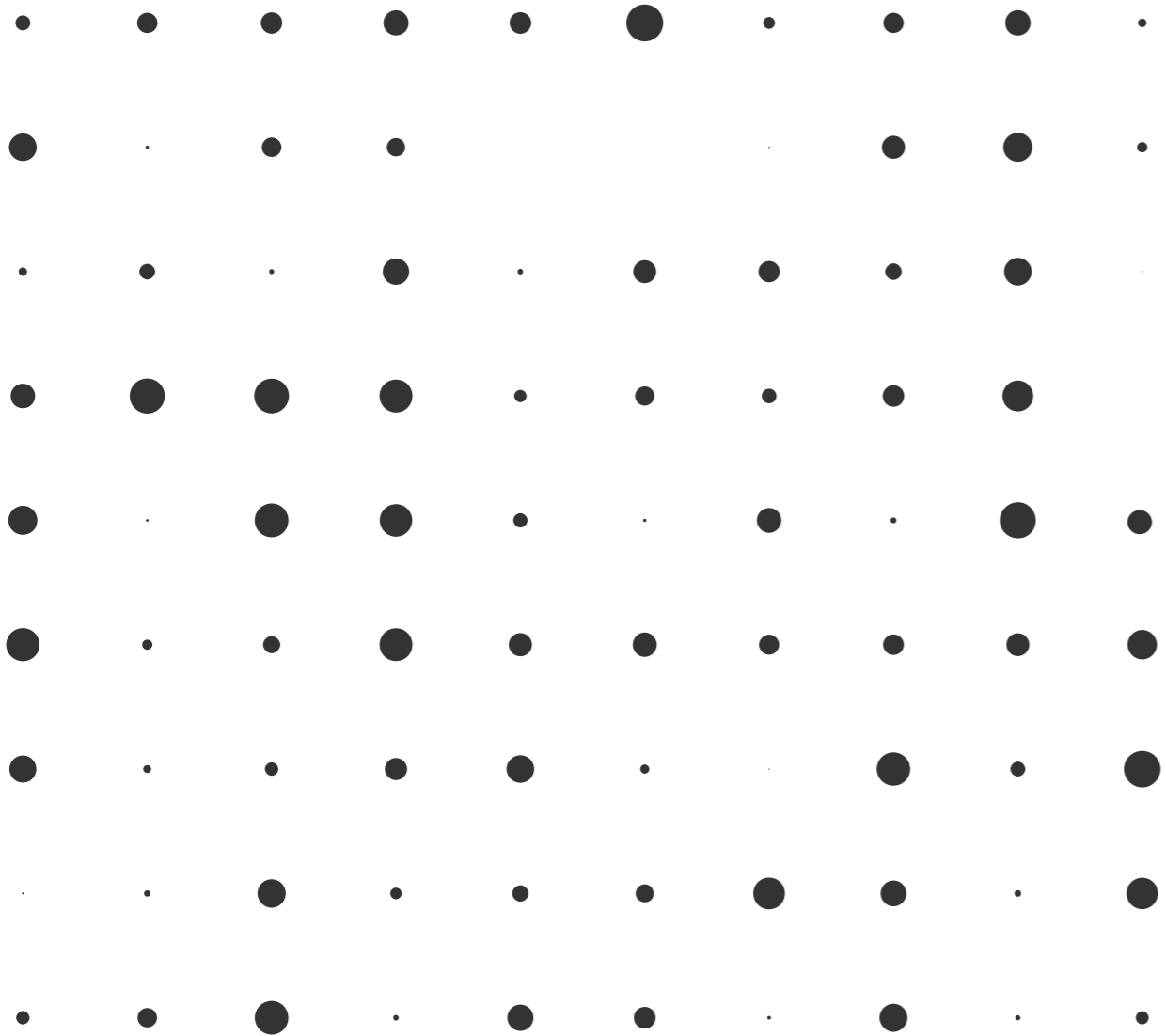

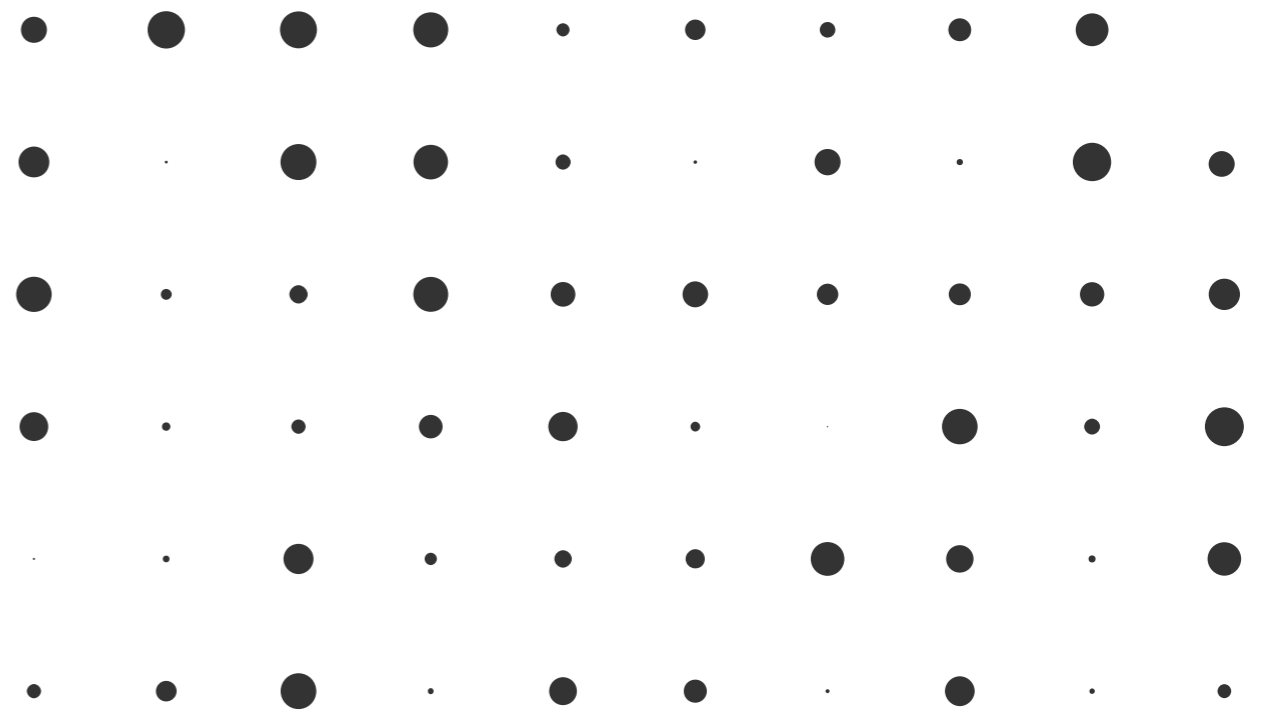
